

**SUMMARY OF PIAA BOARD OF DIRECTORS' ACTIONS FROM THE
MEETING OF WEDNESDAY, MARCH 20, 2024**

1. Approved the Minutes of the February 21, 2024 meeting of the Board of Directors;
2. Held an executive session to discuss personnel matters and active litigation;
3. Received an update on PIAA legislative matters;
4. Addressed the following recommendations, reports, and updates from the Executive Director:
 - The Board unanimously approved the unaudited financial statements for months ending January 31, 2024;
 - The Board unanimously approved a request by Columbia-Montour AVT High School to move up in classification in boys' wrestling for the next cycle;
 - The Board heard a presentation from the Superintendent of Central Columbia School District regarding Article III, Section 8, NOTE of the Bylaws and went into Executive Session to discuss. Upon returning to public session, it was requested to put this item on the May 2024 Board of Directors' agenda in order to give the Board appropriate time to consider Central Columbia School District's issues and arguments;
 - The District Annual meeting schedule has been sent out;
 - The Board unanimously approved the minutes and recommendations of the Sports Medicine Advisory Committee from its meeting of March 4, 2024, and took the following actions:
 - The Board unanimously approved a change to the CIPPE form to move the pre-participation examination date to May 1 from June 1, **effective immediately**;
 - The Board unanimously approved to add a mental health expert to the Sports Medicine Advisory committee, and;
 - The Board unanimously approved to change the junior high heat acclimatization period to 5 days.
 - The Board unanimously approved the Request for Proposals (RFP) to host 2024-25, 2025-26, 2026-27, 2027-28 PIAA Competitive Spirit, Team Wrestling, Individual Wrestling, Swimming & Diving and Basketball Championships;
 - The Board unanimously approved, on a **third and final reading basis, effective July 1, 2024**, a motion to add language to Article XIX, Junior High/Middle Schools, Section 3., Period of Participation;
 - The Board voted unanimously on a **second reading basis**, to remove the interpretation in Article VI, Transfer, Residence and Recruiting, regarding Transfers from Court Assigned School;
 - The Board approved, on a **third and final reading basis, effective July 1, 2024**, to add the definition for the term "Participate" in the Glossary of the Bylaws.

 - The Board received information on the Officials' Appreciation Week for Spring Sports, to be held April 14-20, 2024;
