SUBJECT: <sup>RAL</sup> ELECTION OF OFFICIALS' REPRESENTATIVE(S)

DATE: September 11, 2009

Each PIAA Officials' Chapter in the odd-numbered PIAA Districts may submit a nomination(s) for the position(s) of Officials' Representative(s) to their respective PIAA District Committee by completing and submitting the enclosed form to me, as soon as possible, but no later than Tuesday, November 10, 2009. It should be noted that a PIAA Officials' Chapter is not required to submit a nomination(s) for the position(s) of Officials' Representative(s) to its PIAA District Committee. Again, submission of a nomination(s) by a chapter for the position(s) of Officials' Representative is OPTIONAL.

If a PIAA Officials' Chapter desires to nominate a candidate(s) for the position(s) of Officials' Representative(s) to a PIAA District Committee, the enclosed form should be completed and returned to the PIAA Associate Executive Director, as soon as possible, but no later than Tuesday, November 10, 2009.

To complete the enclosed form properly, each individual(s) who has been nominated by a chapter for the position(s) of officials' representative MUST sign his/her name at the place indicated on the form. Also, the President and Secretary of the Chapter MUST sign his/her name at the place indicated on the form or the nomination WILL NOT BE ACCEPTED.

The incumbent officials' representative does not need a chapter's endorsement to be nominated for the position. The incumbent officials' representative may seek re-election by contacting their district chairman and requesting the submission of their name to the PIAA Office to appear on the ballot.

Following receipt of the nominations, ballots will be mailed to each PIAA registered official residing in the PIAA District requiring an election. The ballots should be completed immediately and mailed to the PIAA Office.
