SUMMARY OF PIAA BOARD OF DIRECTORS' ACTIONS FROM THE MEETING OF WEDNESDAY, JULY 19, 2017

WEDNESDAY, JULY 19, 2017

- 1. Approved the Minutes of May 24, 2017 meeting of the Board of Directors.
- 2. Accepted from the Director of Legal Affairs the annual report on the PIAA Foundation.
- 3. Approved Proposed By-Law Amendments, all on a suspended protocol basis, to:
 - amend ARTICLE XIII, PENALTIES, Section 5, Forfeiture of Championships Rights for further clarification to allow for forfeiture of championships rights in lieu of expulsion or suspension of a member school.
 - amend ARTICLE VI, TRANSFERS, RESIDENCE AND RECRUITING, Section 5, Transfers Following Expulsion or Anticipated Expulsion for further clarification relating to sanctions deemed to follow a student to another school.
 - amend ARTICLE IX, REPRESENTATION, AND ARTICLE XVI, SEASON AND OUT-OF-SEASON RULES AND REGULATIONS for further clarification.

Approved Proposed Policies and Procedures Amendments, all on a suspended protocol basis, to:

- amend policies governing Indoor Events and Outdoor Events: Spectator Decorum policies for further clarification relating to sanctions for violations of the policies.
- create a Policy for Merchandising for clarification at District and Inter-District Contests to make clear that PIAA retains the exclusive right to sell souvenir products at these events.
- create a Policy for Public Address Protocol to provide guidance for public address announcers at Contests.
- 4. Referred a request of a member school for determination of the sanction imposed upon a student who violated ARTICLE XVI, Section 2C, of the PIAA By-Laws, pertaining to contact outside the defined football season to the respective District Committee for its consideration.
- 5. Discussed possible member school participation in national events or National Championships. The Board agreed to maintain the status quo supporting the current prohibition of contact outside the defined season for football, but permitting participation in other sports if it would comply with the PIAA By-Laws.
- 6. Discussed an incident where a school refused to participate in a PIAA Inter-District Contest after qualifying through a District. The Board requested the Executive Director to investigate and take any appropriate action.
- 7. Approved the removal of a registered sports' official in all sports, due to his actions.

 - language to change to the Policy Regarding Regular Season Contest Officials' Fees;
 - language to change the Officials' Manual regarding attendance at chapter meetings;
 - the recommendation to eliminate the October in person test date and produce a news release to publicize its elimination, as this was the final in person test scheduled;
 - an increased fee for officiating inter-district play, which is recommended to be raised by \$5.00 beginning the 2018-19 school year; this was referred to the Budget Committee for implementation.

- 23. Accepted the recommendations of the PIAA Track & Field Steering Committee to:
 - adopt the 2018 proposed qualifying standards;
 - amend the PIAA-adopted dual meet tie-breaker to provide that the winning team have one additional point and an asterisk added to its score;
 - eliminate the PIAA modification of the NFHS Rules Book on jewelry for Track & Field and Cross Country and adopt the NFHS Rules Book jewelry rule as written.

Approved the Minutes of the Track & Field Steering Committee, as prepared and presented.

- 24. Accepted the recommendation of the PIAA Baseball Steering Committee to:
 - amend the pitching restriction to permit a pitcher reaching the maximum pitch count for any level of rest during an at bat, to continue to pitch to that batter, or any substitute for that batter, until such batter is put out or reaches first base, or until a third out has been made prior to the end of that at bat. The pitcher will be credited with the maximum number of pitches for that level; and
 - amend the pitching restriction to provide that the pitch counts need to be entered no later than 12:00 pm (noon) the day following a competition.

- **29.** Approved on a first reading basis, to modify the 21 day sit-out rule for in-season, same sport, presumptively eligible transfers to 14 days from the date of enrollment to allow District Committees an opportunity to address these situations.
- **30.** Approved to authorize PIAA Executive Staff to investigate the development of a Web portal to receive the submission of all request for decisions on athletic eligibility.
- **31.** Accepted the Competition Committee Report from its meeting of July 18, 2017.
