### 2021 Officials' "30 Years of Service" Awards Luncheon

PIAA Board of Directors and Staff would like to congratulate and thank the officials who attended the "30 Years of Service" Banquet on August 14th, 2021. There were 85 officials recognized for their many years of service to student-athletes across the commonwealth.

In addition to the "30 Years of Service Awards", PIAA also presents three unique service awards at its annual luncheon; the Beverly M. Owens Gaither Meritorious Service Award,

the Chapter Secretary of the Year Award, and the Mario J. Donnangelo Distinguished Service Award. The Beverly M. Owens-Gaither Meritorious Service Award is awarded to a registered or non-registered official who shows a constant and consistent devotion to PIAA through their years of service. This year's recipient was Edward B. Michael who has become synonymous with the PIAA Wrestling Championships for over 35 years of devotion to the sport. Ed was also an accomplished PIAA-registered baseball umpire for 20 years from 1977 through 2006.

# Reminders for the Upcoming School Year

Mandatory Rule Interpretation Meetings must be attended by a Head Coach. Failure to attend will result in an **\$100.00 fine**.

Eligibility lists are due within two weeks of the First Regular Season Contest Date. Failure to accurately and electronically submit the Certificate of Eligibility and subsequent modifications within two (2) weeks after the First Regular Season Contest Date will result in the imposition of a fine of **\$100** per sport. Any modifications to the Certificate of Eligibility shall be timely submitted throughout the season.

- Enrollment numbers need to be submitted to the PIAA from **October 1, 2021**, **until October 15th, 2021**. Numbers will be submitted using your school code through the PIAA website.
- School administrators should check to make sure officials have updated clearances. Login using your school access code and view the Officials' Registry. Any officials not found in the registry are not properly registered and should not be contracted to officiate.
