SUMMARY OF PIAA BOARD OF DIRECTORS' ACTIONS FROM THE MEETING OF WEDNESDAY, JULY 13, 2022

- 1. Introduction of recently elected members of the 2022-2023 PIAA Board of Directors;

- **3.** Approved the Minutes of the May 18, 2022, meeting of the Board of Directors;
- **4.** Held an executive session to discuss active litigation;

- 6. Unanimously approved, on a **suspended protocol basis**, the 2022-2023 Operating Budget and Cash Flows Budget;
- 7. Approved the appointment of the Executive, Compliance, Human Resources, Budget, Nominating, Policy Review and Strategic Planning Committees.
- **8**. Conducted a hearing and approved a request by a member high school to suspend the application of Article VI, Section 6, of the PIAA By-Laws.
- 9. Addressed the following recommendations, reports, and updates from the Executive Director:
 - The Executive Director reported on the 103rd NFHS Summer Meeting, which was held June 27 thru July 1, 2022, in San Antonio, Texas;
 - The Board unanimously approved the PIAA unaudited financial statements for the month ending April 20, 2022;
 - The Board unanimously approved the minutes and recommendations from the June 20, 2022 meeting of the PIAA Strategic Planning Steering Committee, and acted on the following recommendations of the Committee:
 - The Board unanimously voted, **on a first reading basis**, to recommend that the membership approve an amendment to the PIAA Constitution to modify the language in Article IV, Annual Dues and Enrollment;
 - The Board unanimously voted, on a first reading basis, to approve an amendment to Article VIII, Period of Participation, Section 6, B2, of the PIAA By-Laws to modernize the language;
 - The Board unanimously voted, **on a third reading basis**, to amend Article XIII, Penalties, Section 3A, of the PIAA By-Laws to add language confirming that (1) forfeitures cannot be rescinded, and (2) mandatory forfeitures are not subject to appeal, **effective immediately**;
 - The Board unanimously voted, **on a first reading basis,** to amend Article XVI, Season and Out of Season Rules and Regulations, Section 2, A3, of the PIAA By-Laws to address teams that are sponsored by, rather than affiliated with, a school;
 - The Board unanimously voted, **on a suspended protocol basis**, to amend the language of Article XIII, Penalties, Section 8D, Disqualification from the Last Contest of the Season, of the PIAA By-Laws, to add the two-game sit-out for a supplemental disqualification to this section, **effective immediately**.

 - The Board voted, **on a first reading basis**, to recommend that the membership amend language in Article IX, District Committees, Section 1. B., Method of Selection, of the PIAA Constitution;
 - The Board unanimously voted, **on a first reading basis**, to amend the "All-Star rule," as set forth in Article IX, Representation, Section 2, of the PIAA By-Laws to modernize the language;

- The Board voted, **on a first reading basis**, to amend the Competition Formula to (1) drop the inclusion of transfer students as a factor; and (2) include all Team sports within the scope of the policy;
- The Board voted, on a first reading basis, to adopt a policy to address Name, Image and Likeness, (NIL) for student-athletes;
- The Board voted, on a first reading basis, to amend the Designation of Enrollment Classifications
 Policy to eliminate the additional enrollment count of 10% of the students who are not regularly
 enrolled and in full-time attendance;
- The Board unanimously voted, on a first reading basis, to amend language of Article III, Attendance, Section 8A, Multi-School Academic Arrangements, of the PIAA By-Laws, to indicate if a conflict exists between the schools involved, the school of residence takes preference;
- The Board unanimously voted, on a first reading basis, to amend Article III, Attendance, Section 8B, Students placed by Court Order or as a Result of Disability, of the PIAA By-Laws to make clear at what school the student is eligible:

- **14.** Approved a change to the Spring sports season in the sports of boys' volleyball, and girls' and boys' lacrosse to extend the district deadline by one week;
- **15.** Approved the selection for Cablecast/Telecast and Video Streaming Services of the PIAA Championships (Finals) for a four (4) year period beginning July 1, 2022, and ending June 30, 2026, as follows:

Team and Individual Wrestling – Flo Sports Cross Country, Volleyball, Field Hockey, Soccer, Football, Competitive Spirit, Swimming & Diving, Golf, Basketball, Track & Field, Lacrosse, Softball and Baseball – Pennsylvania Cable Network (PCN)

- **16.** Discussed and voted unanimously to continue with the long established open meetings policy;
- 17. Discussed the NFHS Foundation and its provision of 375 Wet Bulb Globe Thermometers for use by PIAA member schools and the manner which these items may be distributed to the requesting member schools;
- **18.** The Board unanimously approved the initial legislative Interpretation of ACT 66;
- 19. Unanimously approved, on a **suspended protocol basis and effective immediately**, an amendment to Article XV. Officials, Section 8. Suspension. A., of the By-Laws, to authorize suspension of registered sports officials who violate, cancel or alter proposed contracts with PIAA member schools without the consent of the other contracting party;
- 20. Unanimously approved, on a suspended protocol basis and effective immediately, an amendment to Article XIII, Penalties, Section 8, Disqualification from Next Contest(s), B. Supplemental Disqualification, Two Game Suspension, of the By-Laws to clarify actions that implicate a supplemental disqualification;

- 21. Unanimously approved, on a **suspended protocol basis and effective immediately**, an amendment to the Officials' Manual, Responsibilities and Duties of the District Officials' Representatives, Section 1; that District Officials' Representatives are not authorized or empowered to participate in any proceedings or negotiations with any league or member school;
- 22. Unanimously approved on a **first reading basis**, an amendment to the PIAA Policies & Procedures, Evaluation of Officials: Evaluation of PIAA District Championships Contest Officials, to indicate that District Chairs, or their delegees, are the individuals with the authority to assign evaluators for District Tournament Contests;
- **23.** Accepted the following reports from the Assistant Executive Director:
 - The Board received an update regarding PIAA's initiative of Title IX's 50th Anniversary;
 - The Board received a review of the PIAA Boys' Team & Singles and Doubles Tennis Championships;

 - The Board received a report on coaches and contestants ejected from the 2022 Regular Season and Postseason Contests in spring sports.
