2022 Officials' "30 Years of Service" Awards Banquet

PIAA Board of Directors and Staff would like to congratulate and thank the officials who attended the "30 Years of Service" Banquet on August 6th. There were 70 officials recognized for their years of service to student-athletes across the commonwealth.

In addition to the "30 Years of Service Awards", PIAA also presents three unique service awards at its annual banquet; the Beverly M. Owens Gaither Meritorious Service Award, the Chapter Secretary of the Year Award, and the Mario J. Donnangelo Distinguished

Service Award. The Beverly M. Owens-Gaither Meritorious Service Award is awarded to a registered or non-registered official who shows a constant and consistent devotion to PIAA through their years of service. This year's recipient was Barry L. Heckard (pictured to the right) who is one of the mainstays with the PIAA Wrestling Championships since 1979, devoting over 42 years of service to the sport. Barry was a graduate of Mechanicsburg HS and was a threesport athlete competing in football, wrestling and baseball.



The Chapter Secretary of the Year award goes to a chapter secretary who was nominated by their officials' chapter for showing leadership and commitment to their



chapter's officials. This year's Chapter Secretary of the Year award went to Terrance P. Fustine (pictured to the left), who was the Chapter Secretary for the Northwest Mountain Chapter of PIAA Football Officials. Terry has been the chapter secretary since 1999. He has worked tirelessly, providing information to his chapter officials. Terry also is the assignor for junior high, junior varsity, and varsity level athletics, ensuring area schools have officials at their weekly athletic events.

The Mario J. Donnangelo Distinguished Service Award is the highest award the PIAA bestows on a registered sports official. The recipient of this award was Pam Cherubin (pictured below), District VII, female PIAA Officials representative. Pam has been the

District VII female officials representative for 40 years. Pam was a graduate from Rosalina HS where she played basketball. She has been a registered basketball official since 1971 and has officiated not only in high school but in all three college divisions.

Congratulations to these three distinguished individuals on their well-deserved awards.

16th Annual PIAA Foundation Cross Country Invitational

Saturday, September 24th, PIAA will be hosting the 16th Annual Cross Country Invitational at Parkview Cross Country Course in Hershey. Team entries will be accepted on a first come, first entered basis. Individual entries from students representing PIAA member schools that DO NOT sponsor a cross country Team during the Regular Season that participates in at least 50% of the maximum permitted number of Regular Season Contests in that sport, will be accepted. Those students must meet all PIAA eligibility requirements, must wear a school-issued cross country uniform, and will not be eligible to receive a Team score. Teams that wish to participate in the varsity race with less than five runners, will be permitted to do so; however, they will not be eligible to receive a Team score. Reminders for the Upcoming School Year

- Mandatory Rule Interpretation Meetings must be attended by a Head Coach. Failure to attend will result in an **\$100.00 fine.**
 - Fall sport rule interpretation meetings are wrapping up. Coaches who have missed the meeting can view a rules interpretation meeting online from 8/30-9/30 by logging into their coaches profile and clicking on Rules Interpretation Meetings on the right side bar and paying the \$75.00 fee.
- Eligibility lists are due within two weeks of the First Regular Season Contest Date.
 Failure to accurately and electronically submit the Certificate of Eligibility and subsequent modifications within two (2) weeks after the First Regular Season
 Contest Date will result in a fine of \$100 per sport. Any modifications to the
 Certificate of Eligibility shall be timely submitted throughout the season.
- School administrators should check to make sure officials have updated clearances.
 They can do this by logging in using their school access code and click view the
 Officials' Registry. Any officials not found in the registry are not properly
 registered and should not be contracted to officiate.
