SUMMARY OF PIAA BOARD OF DIRECTORS' ACTIONS FROM THE MEETING OF WEDNESDAY, MAY 17, 2023

- 1. Approved the Minutes of the March 22, 2023 meeting of the Board of Directors;
- **2.** Held an executive session to discuss personnel matters and active litigation:
- 3. Addressed the following recommendations, reports, and updates from the Executive Director:
 - The Board unanimously approved the unaudited financial statements for the months ending February 28, 2023 and March 31, 2023;
 - The Board received an update on the District Annual Meetings and approved the tally of the votes on (4) proposed amendments to the PIAA Constitution, all of which passed by overwhelming support:
 - 1. Amendment to ARTICLE IV, ANNUAL DUES AND ENROLLMENT REPORT, Section 1., of the PIAA Constitution, to make clear that the Board of Directors has discretion to establish criteria for sport classifications, **effective July 1, 2023**;
 - 2. Amendment to ARTICLE V, Section 1. Pennsylvania Interscholastic Athletic Association, Inc. (PIAA) Districts, of the PIAA Constitution, to make clear that Teams are eligible to participate in the postseason competition only in the PIAA District in which they are a member, effective July 1, 2023;
 - 3. Amendment to ARTICLE IX, DISTRICT COMMITTEES, A. Composition and Selection, of the PIAA Constitution, to clarify provisions relating to persons serving on District Committees, **effective July 1, 2023**;
 - 4. Amendment to ARTICLE IX, DISTRICT COMMITTEES, Section 2. Officers., of the PIAA Constitution, to require that District officers be employed by a PIAA District, effective July 1, 2026;
 - The Board unanimously approved, on a third and final reading basis, and effective July 1,
 2023, a motion to accept PIAA sponsorship and jurisdiction of girls' wrestling as a sport;
 - The Board unanimously approved the minutes and recommendations of the PIAA Strategic Planning Committee from its meeting of May 2, 2023, and took the following actions relating to:
 - The Board approved, on a first reading basis, a motion to modify the Competition Formula to include all team sports and to further explore issues relating to adding sports which have individual components;
 - The Board approved, on a **second reading basis**, a motion to clarify the Competition Formula to confirm that when a Team that moves up in classification pursuant to the Competition Formula, that sport classification becomes the baseline classification for that Team in that sport in the next cycle.
 - Information was presented on the upcoming 104th NFHS Summer Meeting, to be held June 28
 July 1, 2023 in Seattle, Washington;
 - The Board received information on the NFHS Summer and Legal meetings;
 - The Board received and reviewed the 2023-2024 Board of Directors' meeting schedule;
 - The Board unanimously voted to approve, on a first reading basis, a restructuring and reorganization of ARTICLE VI, TRANSFERS, RESIDENCE AND RECRUITING, of the PIAA Bylaws;

- The Board unanimously approved, on a first reading basis, an amendment to ARTICLE II, AMATEUR STATUS AND AWARDS, Section 3., J., Violation of NIL, of the PIAA Bylaws to add enforcement criteria for Name, Image and Likeness limitations;
- The Board unanimously approved, on a first reading basis, a motion to add language to SPORTSMANSHIP AND UNSPORTSMANLIKE CONDUCT, Section 1, Schools and Their Athletic Personnel, of the PIAA Bylaws, to address certain inappropriate conduct;
- The Board unanimously approved a motion to have the Executive Staff draft language to add to ARTICLE XII, Section 5 A., to address the impact of a Contest cancelled by threats and/or intimidation of a Team;
- The Board unanimously approved, on a first reading basis, a motion to add language to ARTICLE XIII, PENALTIES, Section 2, Suspension, of the PIAA Bylaws to include provisions certain unacceptable conduct.

 - The Board received a review of the PIAA Basketball Championships held March 23, 24 and 25, 2023 at the GIANT Center;

 - The Board voted to table and refer to District Committees a proposed change in policy regarding the use of pep bands at indoor Contests.
 - The Board received an update on the Boys' Team Tennis Championships to be held May 19 & 20, 2023 and the Boys' Singles & Doubles Tennis Championships to be held May 26 & 27, 2023, in Hershey;
 - The Board received an update on the Boys' Volleyball Championships to be held June 17, 2023 at Penn State University.

 - The Board unanimously approved a motion to modify NFHS Wrestling Rule 4-5 Weighing in, to provide that an athlete must be eligible in all respects in order to participate in weigh-ins;
 - The Board unanimously approved, on a one year trial basis, a motion to permit Conferences and/or Leagues to modify the length of sub-varsity periods in the sport of wrestling;
 - On a first reading basis, the Board approved a motion to incorporate girls' wrestling qualifiers into the 2024 PIAA Wrestling Championships at the GIANT Center, scheduled for March 7-9, 2024, and possibly utilizing up to a 16- wrestler bracket.
