## SUMMARY OF PIAA BOARD OF DIRECTORS' ACTIONS FROM THE MEETING OF WEDNESDAY, JULY 17, 2024

- 1. Introduction of recently elected members of the 2024-2025 PIAA Board of Directors;
- Conflict of interest statement for Board of Directors was emailed for completion and discussion of any possible circumstances;
- **3.** Approved the appointment of the Executive, Compliance, Human Resources, Budget, Nominating, Policy Review and Strategic Planning Committees;
- **4.** Approved the Minutes of the May 15, 2024 meeting of the Board of Directors;
- **5.** Held an executive session to discuss personnel matters and active litigation;
- 6. The Board denied the request from Garnet Valley High School student for a waiver of Article I, Section 3., Waiver of Maximum Age Rule and Article VIII, Period of Participation, of the PIAA Bylaws;
- 7. The Board voted to rescind the District VII decision, of Article VI, Section 7, Postseason Eligibility, of the PIAA Bylaws and to grant postseason eligibility to a student at Knoch High School.
- **8.** Addressed the following recommendations, reports, and updates from the Executive Director:
  - The Board unanimously approved the unaudited financial statements for months ending April 30, 2024 and May 31, 2024;
  - The Board received a report from the 105<sup>th</sup> NFHS Summer Meeting held June 28- July 1, 2024 in Boston, MA, which included;
    - Roy Snyder swimming coach for 59 years at Wilson High School was recognized by the Board for his induction to the NFHS Hall of Fame in the Class of 2024;
    - Dr. Robert A. Lombardi is the new president of the National Federation of State High School Associations (NFHS) for the 2024-2025 school year.
  - The Board unanimously approved the minutes and recommendations from the Strategic Planning Committee from its meeting of June 12, 2024, and took the following action;
    - The Board accepted the recommendation to continue overtime for regular season soccer matches;
    - The Board voted, on a first reading basis, to remove from the table and approve expanding girls' volleyball to six (6) classifications for the next cycle (2026);
    - The Board unanimously approved, on **a first reading basis**, to eliminate language in the Competition Formula regarding Postseason eligibility;
    - The Board unanimously approved, on a first reading basis, to change the number of transfers in Team sports from those that had minimally 1 to 2 and those sports that had 3 to 4 transfers for the next cycle;
    - The Board unanimously approved, on a first reading basis, that 1 competition point will be awarded for the round of 16 to be consistent with all bracketed Team Sports;

- The Board unanimously approved, on **a first reading basis**, that the number of competition points to stay up in a classification would be 4, 5, or 6 with utilizing 7 points to move up in class and the number of competition points awarded to possibly move down would be 1, 2, or 3, all dependent upon transfers;
- The Board unanimously voted to table and remand back to the Strategic Planning Committee for more discussion, (1) a school winning two consecutive PIAA championships in one classification cycle will automatically move up, regardless of their number of transfers or lack of transfers and (2) a school obtaining 7 points, winning a championship, and having transfers will move up a classification;
- The Board will refer back to the Strategic Planning Committee for further discussion, some items but not limited to the following; voluntary upgrades, transfers, non-varsity participation, and any research topics;
- The Board unanimously approved, on a **first reading basis**, to remove language under the appeals section of the competition formula, on limitations of an appeal;
- The Board unanimously approved to **suspend protocol and effective July 1, 2024**, to extend the PIAA Basketball Championship dates to March 27, 28 & 29, 2025.
- Reviewed Assistant Executive Director's comprehensive report of the Competition Formula results since its inception by cycle and sport.
- The Board unanimously approved the minutes from the Diversity, Equity, Inclusion and Belonging Committee from its meeting of June 19, 2024,
- The Board unanimously approved the minutes and recommendations from the Parent Advisory Committee from its meeting of June 20, 2024, and took the following action;
  - The Board unanimously approved the alternate voting representatives to the Board of Directors for the 2024-2025 and the 2025-2026 school years for the Parent Advisory Committee, .
  - The Board recommended the following statement be read by public address announcer at member schools before each contest:
    - Insert school name here and PIAA promote the highest ideals of good sportsmanship. Actions or language meant to demean contestants, teams, spectators, and officials are not in the highest ideals of interscholastic education and will not be tolerated. Let today's contest reflect mutual respect. We request your cooperation in supporting todays' contestants and contest officials in a positive manner. Offensive and unsportsmanlike language or conduct will not be tolerated and may serve as grounds for removal. Please respect our student-athletes, coaches, contest officials and game administration with your cooperation to promote a safe, positive game environment. Thank you.
- The Board unanimously approved the minutes from the Athletic Directors' Advisory Committee from its meeting of June 20, 2024.
- The Board unanimously approved, to suspend protocol, and effective July 1, 2024, to add language to Forfeiture of Contests, in the Rules and Regulations section of the PIAA Handbook, to clarify any Coach or Team Personnel removed, ejected or disqualified from a Contest and refuses to leave the competition area, will result in a forfeiture of the Contest.

- The Board unanimously voted on, first reading basis, to direct Executive Staff to draft amended language for clarity and have legal review regarding Article III, Section 8, NOTE of the Bylaws, to be presented at the September Board of Directors' Meeting.

- The Board received information on the 29<sup>th</sup> Annual Officials' Convention to be held August 2 & 3, 2024.

  - The Board unanimously approved, on a **first reading basis**, to accept the 2024-2025, 2025-2026, Winter Sports Maximum Number of Qualifiers and Brackets;

    - The Board unanimously voted to adopt the 2025 proposed qualifying standards as presented.

    - The Board unanimously approved to require schools to modify the pitch count in MaxPreps to indicate the proper number of pitches and the required days of rest;
    - The Board unanimously approved to recommend field dimensions of a minimum of 300 feet down each foul line and 350 feet to center field, in the Tournament Directors' Handbook.
