

**SUMMARY OF PIAA BOARD OF DIRECTORS' ACTIONS FROM THE
MEETING OF WEDNESDAY, MARCH 26, 2025**

1. The Board heard comments from representatives from Education Law Center, Women's Law Project and parents of a member school student regarding the Presidential Executive Order of February 5, 2025.
2. Approved the minutes of the February 19, 2025 meeting of the Board of Directors.
3. Held an executive session to discuss personnel matters and active litigation.
4. The Board received a legislative update from legislative counsel.
5. Addressed the following recommendations, reports and updates from the Executive Director:
 - The Board approved the minutes and recommendations from the Feeder Schools Sub-Committee meeting held Monday, February 24, 2025. The Board held discussion on feeder schools. No action was taken;
 - The Board approved, on a third and final reading basis, an amendment to Article VI, Transfers, Residence and Recruiting, Section 7, C., d., to add retirement and/or discharge from the military for post season waiver, effective July 1, 2025;
 - The Board approved, on a second reading basis, an amendment to Article VI, Section 11. Recruiting of students, B. Out-of-Season Activities, #12, and add New #14, regarding participation in out of season teams and competition;
 - The Board approved the reports requested from member schools;
