30th Annual PIAA Officials' Convention

Nearly 100 officials honored for 30-years of service

MECHANICSBURG, PA – The 30th Annual PIAA Officials Convention took place August 1st and 2nd, 2025 at the Hilton Harrisburg. The Officials' Convention was launched by current PIAA Executive Director Dr. Robert Lombardi in 1994. It started with only 75 officials in attendance and has grown to an average of more than 1,000 officials each year. This convention has also become the largest interscholastic sports officials' convention in the country and continues to hold its place! This is a chance for officials to gain educational knowledge, review rule changes for the upcoming sports season(s), and participate in numerous sessions of the recruitment, retainment and training of officials.

The conference also featured a few specials guests. With the Officials Convention gaining national recognition, the Arkansas Activities Association Associate Executive Director Dex Hill flew in to get a first-hand glimpse to take back ideas to the Arkansas' Officials Clinic. Two of the guest speakers included Robert Hartman, PIAA former vice-president, shared his experiences as an athlete, official, administrator and a PIAA executive and Fred Harris, Athletic Director at Liberty High School in Bethlehem, spoke about how to enhance the relationship between the official and athletic director. Other breakout rooms included Situational Awareness, Leadership Strategies, Junior Officials Clinic, Player Safety and a live Swimming and Diving demonstration at Red Land High School were among the near 80+ sessions.

Beverly Owens-Gaither Meritorious Service Award: Dr. Sam Monismith

This award is bestowed upon a registered or non-registered PIAA official who has consistently shown a devotion to PIAA, interscholastic athletics and the athletes we serve. The award winner shows constant and consistent devotion through their working relationship with PIAA in its many activities. This person will have gained this award through a distinctive period of service to PIAA.

Dr. Sam Monismith was born and raised in Central Pa. He is a graduate of Middletown High School, East Stroudsburg University and Penn State University. Dr. Monismith retired as an associate professor of health education at Penn State.

Dr. Monismith has been a registered Cross Country and Track and Field official since 2011 and has worked many PIAA Track and Field and Cross Country Championships. In addition, he has often worked in support of multiple PIAA Championships as a scorer and registrar, critical positions at these events. Dr. Monismith was mentored by the likes of

This service award is the highest award PIAA bestows on a registered sports official. This award is reserved for those registered sports officials whose leadership and efforts have been of great assistance to PIAA, interscholastic athletics, and the high school athletes of Pennsylvania.

The first of this year's recipients is Audrey K. Hall. She is a proud graduate of Southern Huntingdon High School, Lock Haven University and Penn State University. She has been a registered field hockey umpire since 1992 and a track and field official since 2005.

During Ms. Hall's officiating career, she previously worked the 1998 AA Field Hockey Championships and has worked countless Track and Field Championships. She has served on the District V Committee since 1984, and is the current District V Female Officials Representative. Ms. Hall has also held countless leadership positions in PIAA Officials' Chapters and on the PIAA Board of Directors.

After a 32-year career, Ms. Hall retired from teaching at McConnellsburg High School and has served as an American Red Cross instructor for the last 50 years. She is a current member of the Huntingdon County and Fulton County Halls of Fame. Her real claim to
