

**SUMMARY OF PIAA BOARD OF DIRECTORS' ACTIONS FROM THE
MEETING OF WEDNESDAY, JANUARY 14, 2026**

1. Approved the minutes of the December 3, 2025, meeting of the Board of Directors.
2. The Board held an executive session to discuss personnel matters, and active litigation.
3. The Board received a legislative update from legislative counsel.
4. Addressed the following recommendations, reports, and updates from the Executive Director:
 - The Board approved, on a **third and final reading basis**, effective immediately, to modify Bylaw Article III, Section 5, Alternative School Students, Magnet School Students, and Career and Technology and/or Vocational School Students;
 - The Board approved, on a second reading basis, an amendment to the definition of Open Gym in the Glossary;
 - The Board approved the member schools who requested upgrades in classification by sport and gender;
